



## **Food Service Agreement Contract**

**Lunch Program.** Great Eats Cafe will be providing the lunch program at Saint John Paul academy ii, for the school year 2022-2023 using the Hotlunch.com online portal. Each lunch ordered will include an option for a protein, starch, veggie or fruit, and a drink. There are several meal options to choose from. A variety of additional extras, such as snacks and drinks will be available for purchase inside the cafeteria. These add-ons can also be preordered on our website.

Great Eats Cafe is a full service catering company and is eager to host your child's birthday party at school or any other special occasion. A variety of special event meals, such as Mr. Beast Burgers, pizza, cookies, cupcakes, etc. can be arranged for your child's class.

The service provider, Great Eats Cafe, will need to keep a credit card on file for all students utilizing the cafeteria. All parents and students are responsible for providing payment each day an order is received. Inside the cafeteria students may add on to their accounts with cash or credit cards. In the event that your child does not have lunch, Great Eats will provide them with one of the meal options from that day and your credit card will be charged. Great Eats Cafe reserves the right to report to all applicable credit agencies and debt collectors to collect any payments and fees unable to be processed. Account Holder agrees to be personally responsible for any outstanding balances and any costs of collection including but not limited to attorney fees, court costs, collection fees up to 40%. All accounts subject to interest and late fees as allowed by law.

**Meal Plans.** A yearly plan is offered at \$1645 and receives a 15% discount on all items purchased through the cafeteria and is to be paid in full by **August 31st, 2022**. The yearly plan is non-refundable and funds are to be used during the school year that it was purchased in. Any leftover funds will be used towards families in need.

All funds will be placed in your child's account and it is the responsibility of the student and parent to order meals each day and monitor the account. The amount of \$1645 is based on the purchase of a basic meal (average entree, side, water, and a fresh-baked cookie) being purchased each school day based on the average 180 day school year. If a student orders a special entree, a more expensive drink (juice, gatorade, etc), or snacks, the account funds may deplete quicker than the end of the school year and need to be replenished to continue ordering. Great Eats Cafe is not responsible if a child uses extra funds in his/her account.

**Refunds Policy and Procedures.** A refund will be provided to all orders canceled via your online Hotlunch.com account 24 hours prior to the lunch date. In the event that your child wakes up sick and is unable to attend school, you must contact Great Eats Cafe via email at [info@greateatscafe.com](mailto:info@greateatscafe.com) by 8:00 am (EST) the morning of, before the lunch is prepared & packaged in order to receive a refund. No refunds will be given on lunches not canceled in a timely manner or on any add-ons purchased; such as snacks and extra drinks.
