Food Service Agreement Contract

Lunch Program. Great Eats Cafe will be providing the lunch program at Saint John Paul II Academy for the school year 2021-2022. Each lunch ordered will include a protein, starch, veggie or fruit, and a drink. There are several meal options to choose from. There will be no substitutions of meals allowed, unless a student has provided a doctor's note explaining just cause. A variety of additional extras, such as snacks and drinks will be available for purchase inside the cafeteria. These add ons can be preordered on our website. Great Eats Cafe is a full service catering company and is eager to host your child's birthday party at school or any other special occasion. A variety of special event meals, such as Mr. Beast Burgers pizza, cookies, cupcakes, etc. can be arranged and delivered to your child's class.

The service provider, Great Eats Cafe, will need to keep a credit card on file for all students utilizing the cafeteria. All parents and students are responsible for providing payment each day an order is received. Inside the cafeteria students may add on to their accounts with cash or credit cards. In the event, your child does not have lunch, Great Eats will provide them with one of the meal options from that day and your credit card will be charged. Great Eats Cafe reserves the right to report to all applicable credit agencies and debt collectors to collect any payments and fees unable to be processed.

A yearly meal plan is offered at a discounted rate of 15% if paid in full by August 31st, 2021. This plan includes one complete lunch; protein, starch, veggie or fruit, and a drink. This is yearly savings of **\$425.88**. This can be paid in full or broken up over the course of **9** payments due Monthly throughout the year. However if selecting the monthly option there are no cancelations and money must be paid in full or discount will be removed retroactively.

Additional meals, snacks, and drinks may be purchased and will receive the extra **15%** discount at time of order for all who take part in this savings plan. Please note you must sign up and pay in full to receive the discounted price throughout the duration of the school year. All funds will be placed in your child's account and it is the responsibility of the student and parent to order meals each day and monitor the account. If a student orders a meal, extra drink, and snack the funds will be taken from his/her account and the account may deplete quicker than the end of the school year. Great Eats Cafe is not responsible if a child uses extra funds in his/her account. There are monitoring options, such as putting a hold or not allowing snacks to be bought.

Refunds Policy and Procedures. A refund will be provided to all orders cancelled 24 hours prior to the lunch date. In the event your child wakes up sick and is unable to attend school, you must contact Great Eats cafe first thing in the morning before the lunch is packaged to receive a refund. No refunds will be given on lunches not cancelled in a timely manner or on any add ons purchased; such as snacks and extra drinks.
